Relieving poverty, starvation and disease.


Mission World Aid continued to focus on supporting self-sustainable community development in collaboration with partner organisations, particularly by continuing the partnership agreement with Rick Rupp managing Clean Water 4 Life in the Solomon Islands.



The partnership has completed it's 8th year and continues to be fruitful as the CW4L drilling teams continue to impact lives across the Solomon Islands.

Rick continues to be our Development Partner, now residing in the USA. On the ground in the Solomons, Richard Irosea continues in the role of National Manager for CW4L. Richard has been with CW4L for over six years and has been a member of parliament in the Solomon Islands.

At time of writing CW4L has completed 1,468 wells providing villages, schools, churches and clinics / hospitals access to reliable clean water for the first time ever, helping to transform life for at least 331,000 people, which is ~45 % of the rapidly growing total population of the Solomon Islands!



CW4L's five-year plan through to 2024 was to reach all parts of the Solomon Islands, completing a total of about 1,300 wells and ensuring 90% of the population in need of clean water get it. The resulting improvements in health, safety (especially of girls and young women) and convenience help set a foundation for small communities to focus more on education and to make further improvements to their village.



The projected number of wells was reached well before schedule, but there are still areas in need and the work continues with leadership now in local hands.

Donations through MWA supported the completion of 9 wells in 2022-2023, out of a total over 138 during that time. 140 MWA funded wells since 2016 have averaged 226 people impacted per well, reaching over 31,600 people, including over 7,750 children in 23 schools.

Wells funded by MWA since 2016 have been provided on Guadacanal, Malaita and on remote New Georgia and San Christobel. CW4L has reached other islands as well. Rick Rupp reports on each well, and the cumulative impact of this work is truly historic. We are blessed to be in support of what God is doing in the Solomon Islands! The average cost per capita to bring sustainable clean water access to a typical village of 237 people is about AUD \$15 per person. Many wells can serve each community for decades, depending on maintenance and repair, making the real average cost of clean and safe water supply less than \$2 per person per year.





MWA sponsored wells completed in 2022/2023 (pictured below) have been for a cluster of smaller, very remote communities in Marau Sound, Guadalcanal. You must take a boat or ship to travel from Honiara to Mauru Sound. The wells are a lifechanging experience for these communities. Prior to CW4L coming, the people used streams which are no longer safe for drinking.

There will be changes in the coming year as Mark Lerch, Director of the Youth With a Mission base in the Solomon Islands, takes on responsibility for reaching the remote Western Solomon Islands. YWAM has secured a yacht and crew able to reach the islands and drill the wells, as well as a source of funds through the YWAM foundation in Switzerland! Rick Rupp has passed the baton for that part of the work to Mark and YWAM.

CW4L will continue operations through Richard Irosea (CW4L Director) managing two drill teams, each with a tractor and trailer rig. They will sink wells on the main islands of Malaita and Guadalcanal. Richard is very optimistic about the future of CW4L reporting that when he was the Premier of Malaita that the Solomon Islands government had too much red tape which kept him from really helping Solomon Islanders, but over the years of serving as CW4L Director his heart has been fulfilled as he got to experience the shouts of joy and many tears of joy (usually from women) when providing a free water well! So he is determined to keep things operating while the need exists.

The shop continues to run smoothly and it is worth noting some of the particular responsibilities staff carry. While the shop is kept clean and tidy by all the volunteers, Ruth SW does play a key role here and it is so appreciated. Judy meticulously continues to tally weekly earnings and to prepare dockets for our accounts. Denis is a great help with bins and bales and can always be relied on to give a hand even during shop closures. Both he and Andrew set up bunting and a gate to control donations at Christmas and it was a great success. Mary keeps our shop open on a Saturday, a hard to fill roster and always seems to surprise us with her half-day takings! Jill continues to bring in quality items, and give wise leadership to the team especially in the area of valuations. Peter Jansen also values items (eg cameras and clocks) for me and takes things home for minor repairs. Susan and Amanda are cheery souls both always finding tasks that increase sales and make the shop more attractive. As always a few more volunteers would be great! Although we have all our bases covered it is good to have 2 doing a roster.

Our 1/2 price sale in October last year helped move winter stock. During Xmas we shut down and Ruth SW with her brother painted the stairs gloss white. They look much more attractive, and make the shop brighter and easier to clean! We are now giving surplus clothing to The Hut, a local charity in Aldgate, and substandard items to the Hahndorf animal shelter.

Trevor Radbone is invaluably continuing the role of Treasurer for MWA and administrator with financial responsibility in Australia for the India Inland Mission, with which MWA has a long association.

Financial donations are essential and enable the aid to be delivered. During 2022-2023 we received donations of \$36,884 enabling MWA to support a number of partner organisations delivering aid, and especially to support the Clean Water 4 Life partnership with Rick Rupp.

We continue to receive donations of used goods from individuals and organisations for the Mission Shop, some of which is re-directed for humanitarian overseas aid.

Australian House of Prayer for All Nations also helped spread news of progress made by Clean Water 4 Life.

In conjunction with Australian House of Prayer for All Nations, MWA made new connections in 2022-2023, particularly through the South Pacific House of Prayer. MWA continues membership of the Australian Council For International Development (ACFID) and has networked with local and overseas aid organisations. Accountability and openness are important to our association and our connections with others in the field help to develop our processes and expertise. We have longstanding relations with churches and mission organisations in Australia and in many nations.

- d. To establish communication links with missionaries, missions and other aid organisations and supporters through whatever means of communication are appropriate.
- e. To encourage Australians of the Christian faith to embark on any project in Australia or overseas which assists the people in that country. For example, such projects may be to assist with education, agriculture, health care, and building and construction projects, but are not limited to those types of projects;
- f. To support and encourage the training of indigenous people with a view to those people contributing their taught skills and expertise to their country's development.
- g. To make available any necessary information that people require to enable the promotion of the above objectives;
- h. To hold meetings at which local and overseas missionaries may speak.

During 2022-2023 the Mission World Aid team was committed to meeting these objectives.
